First Major Cloud Provider, Microsoft, Adopts International Cloud Privacy Standard

Cloud computing is not without risk. Various data protection laws require businesses to safeguard and protect the privacy of personal information stored in the cloud. As a result, businesses must assess and address information security and privacy risks before becoming a customer of a cloud services provider and entrusting personal information to that provider.

On August 1, 2014, the International Organization for Standardization (ISO) issued ISO/IEC 27018, a standard for protecting personal information stored in the cloud. On February 16, 2015, Microsoft announced that it had become the first major cloud provider to adopt ISO/IEC 27018, which required Microsoft to take certain steps (among others) to protect the privacy of personal information stored in the Microsoft Cloud.

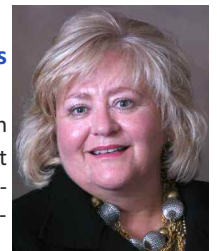

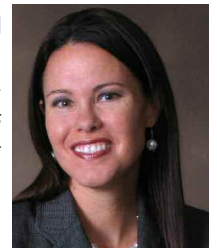
